Terms and Agreement

1. I agree that if in the event that the photo booth is non-operational prior to my event that I will receive a full refund. During the event if the photo booth becomes non-operational than I will receive a prorated amount refunded to me. The amount of the refund is not to exceed the full amount paid.
2. A non-refundable deposit of \$100 is required to secure date and time of the event unless bundled with DJ Mad Maxx's DJ show. The full amount due is required (7) days prior to the event. If payment is not received (7) days prior to the event, the deposit is forfeited. If you need to reschedule your event, we will reschedule your date if your date is available.
3. In the event of circumstances deemed to present a threat or implied threat of injury or harm to MaxxBooths host or MaxxBooths equipment, MaxxBooths reserves the right to cease operation. If the renter of the booth is able to resolve the threatening situation in a reasonable amount of time, 15 Minutes, MaxxBooths shall resume operation in accordance with the original terms and conditions.
4. I agree that a 6' by 8' area will be available along a wall with at least one 15/20 amp circuit outlet from a reliable power source.
5. **** I agree that MaxxBooths may use pictures from our event to publish on their website or in print to show work done or for promotional material used by MaxxBooths with the exception of school or events and children or wherever policies prohibit.
